1. Important safety information

You must always observe basic safety precautions, including the following, when operating electrical products, especially when children are nearby:

All information contained therein serves the safety of the operator. If you ignore the safety instructions, you endanger not only your own health and life but also the health and life of your customers.

MAKE SURE THAT ALL PERSONS WORKING WITH THE GHARIENI TREATMENT TABLE 601 HAVE READ THE COMPLETE OPERATING INSTRUCTIONS AND HAVE UNDERSTOOD ALL INFORMATION AND INSTRUCTIONS CONTAINED THEREIN.

- This instruction manual is an integral part of the product and must be kept in a safe place for possible reference throughout the service life of the appliance. Copies of this instruction manual are available upon request.
- Gharieni Group GmbH is not responsible for any damage caused directly or indirectly to people, animals, or property due to non-observance or noncompliance with the instructions contained in this manual.
- Before you dispose of a treatment table, render it inoperative. This means that you should always pull the power plug and cut the power supply cable on the treatment table. Dispose of it directly with the power plug.
- ★ Keep this instruction manual at hand for when needed. Follow all instructions thoroughly to avoid accidents or damage to the 601.

1.2 Signal words

DANGER! indicates a hazardous situation which, if ignored, will result in death or serious injury.

CAUTION! indicates a hazardous situation which, if not avoided, may result in minor or moderate injury.

WARNING! indicates a hazardous situation which, if ignored, could result in death or serious injury.

NOTICE! indicates a hazardous situation which, if not avoided, may result in possible damage to the treatment table.

1.3 Safety instructions

▲ DANGER!

To reduce risk of electrocution:

- 1. Non-compliance with the instructions in this manual endangers the operator's and customer's health and life and / or can damage the 601.
- 2. All electrical work to connect the 601 to the power supply must be carried out by a qualified professional. Do not modify the power supply. The connection must be carried out in accordance with the current local and legal regulations.
- 3. The mains voltage and the mains frequency **must** correspond to the values indicated on the rating plate.
- 4. Do not make any changes or manipulations to the 601 and / or its power supply (mains cable, mains plug). In case of unauthorised changes or manipulations, **any** warranty of the Gharieni Group GmbH is excluded.
- 5. **Do not connect** the 601 to the power supply if the 601 itself or the power cable or the power plug are visibly damaged.
- 6. The power cable must not be under the 601 except Gharieni Group GmbH expressly allows it. RISK OF ELECTRIC SHOCK!
- 7. Never roll the 601 over the power cable; otherwise you can permanently damage the power cable.
- 8. The power cable must not be located under the adjustable stands or under the optional castors of the 601. Otherwise they can crush the power cable and cause permanent damage. RISK OF ELECTRIC SHOCK!

- 9. Never try to repair the 601 yourself. If the 601 does not operate properly, please contact our customer service or your dealer. Original spare parts should be used only.
- 10. If repair or replacement of the power supply cable and / or the power supply plug is necessary, always commission a qualified specialist (electrical engineer) or a customer service authorized by Gharieni Group GmbH. Never repair or replace them yourself. RISK OF ELECTRIC SHOCK!
- 11. Always disconnect the 601 from the power supply if you are not going to use the treatment table for a long period of time.
- 12. Always disconnect the 601 from the power supply before cleaning and / or maintenance. RISK OF ELECTRIC SHOCK!
- 13. Never use the power cable to pull the power plug. Always pull the power plug itself to disconnect the 601 from the power supply. RISK OF ELECTRIC SHOCK!
- 14. **Never** touch the power plug, the power switch, or other electrical components with wet or damp hands. RISK OF ELECTRIC SHOCK!
- 15. Do not place or store the SPL med close to a source of liquid, such as a bathtub, a shower, or a washbasin. There is danger that the 601 may meet splashed water. RISK OF ELECTRIC SHOCK!

To reduce risk of burns, electrocution, fire, or injury to persons:

- 1. Use only a properly secured safety socket with the appropriate mains voltage. See technical data and rating plate.
- 2. The electric components must not encounter water. RISK OF ELECTRIC SHOCK!
- 3. Check all cables regularly and contact the customer service when any cable is in improper condition. RISK OF ELECTRIC SHOCK!
- 4. Make sure that the power cable is not damaged when the treatment table is moved. Do not step on the power cable. Do not stretch the power cable.
- 5. Always ensure that the power cable is not bent or squeezed during installation.
- 6. Do not use any extension cables, multiple sockets, or adapters. FIRE HAZARD!
- 7. Never open the housing of the electrical control panels. RISK OF ELECTRIC SHOCK!
- 8. No liquids may enter the electrical control panels. RISK OF ELECTRIC SHOCK!

- 9. Never use water or other liquids for treatment or pour water or other liquids over, onto or into the 601! If water or liquids are spilled across or on the treatment table, immediately pull out the power supply plug and dry the 601 thoroughly. RISK OF ELECTRIC SHOCK!
- 10. Never immerse parts of the 601 in water or other liquids! When cleaning the 601, make sure that water never gets into the treatment table itself or its housing. RISK OF ELECTRIC SHOCK!
- 11. If the treatment table is equipped with the heating system (optional equipment), the cables are located between the upholstery and the underframe. The upholstery may only be removed by persons authorized by Gharieni Group GmbH.
- 12. If your 601 is equipped with the optionally available heating system, do not place heavy blankets, clothing or similar on the upholstery while the heating system is switched on. RISK OF DAMAGE! RISK OF BURNS!
- 13. People with acute pain, venous disorders, low blood pressure, inflammatory processes and other medical conditions that make heat applications or this form of client positioning questionable must always consult a doctor before use.
- 14. Never use the 601 on people who are under the influence of alcohol or drugs.
- 15. Only operate or store the 601 in a dry place.
- 16. Always keep the 601 under close observation when used by, on or near children and / or people with reduced physical, sensory, or mental capabilities or lack of experience and knowledge.
- 17. The 601 may only be used for its intended purpose, as described in this instruction manual. Do not use any accessories / devices that are not recommended by Gharieni Group GmbH.
- 18. Never operate the 601 if the power cable or plug is damaged, if the 601 is not working properly if it has been damaged or if it has become wet. Take the 601 to a service centre authorized by Gharieni Group GmbH for inspection or repair.
- 19. In case of defects or malfunctions of the treatment table, contact customer service **immediately**. Use of the treatment table **must** be discontinued until the problem has been solved to avoid further damage to property and persons.
- 20. Regularly remove any dust build-up from the mains plug, the safety socket, and all electrical plug connections, e.g. with a commercially available vacuum cleaner. RISK OF FIRE!
- 21. Keep the power cable away from heated surfaces.
- 22. Never put or insert objects of any kind into any opening (s) of the 601.
- 23. **Never** use the 601 outdoors.

- 24. Make sure that the 601 is only operated by authorized persons.
- 25. Make sure that the 601 is on an even surface when in use.
- 26. Never put any objects containers with liquids of any kind on the 601. This could damage the treatment table and the material. RISK OF ELECTRIC SHOCK! RISK OF DAMAGE!
- 27. All repair or maintenance work may only be carried out by personnel authorized by the Gharieni Group GmbH. RISK OF ELECTRIC SHOCK! FIRE HAZARD!
- 28. Never use a steam cleaner for cleaning. RISK OF ELECTRIC SHOCK!
- 29. Do not support or stand on any area of the bed surface or the support structure / base of the 601. Do not exert any strong physical force on the parts mentioned. Otherwise you can permanently damage the support structure / base of the treatment table. RISK OF TIPPING! BREACH DANGER! RISK OF INJURY!
- 30. When adjusting the bed surface, there must be no people, parts of the body, animals or objects between the base and the bed surface. RISK OF CRUSHING!
- 31. When setting the treatment position, make sure that there are no body parts or objects between the bed components. RISK OF CRUSHING!
- 32. Do not use the base as a footrest. RISK OF DAMAGE!
- 33. Make sure that the 601 is always firmly on its adjustable stands or that the castors are always locked. If the 601 is standing solely on the movable castors, there is a RISK OF ROLLING AWAY!
- 34. Do not move the 601 on its castors while there are people or loads on the 601. Otherwise you will damage the construction / substructure of the 601 and its castors. RISK OF INJURY! RISK OF DAMAGE!
- 35. The 601 must never (neither with nor without castors) be used to transport people or heavy loads. RISK OF INJURY! RISK OF DAMAGE!
- 36. While unpacking, the packaging materials should be kept away from children, pets, or persons with reduced mental capabilities. RISK OF INJURY! CHOKING HAZARD!
- 37. Always keep children and animals out of reach of the 601.
- 38. Children should **never** play with the 601 or any of its components.
- 39. The 601 must not be used by persons with reduced physical, sensory, or mental capabilities or a lack of experience and / or knowledge unless they are supervised or instructed in the safe use of the 601 and understand the hazards involved.

NOTICE!

- 1. **Only lift the 601** <u>vertically</u> off the pallet. Non-compliance with this instruction could seriously damage the stands / castors of the 601.
- 2. For safety reasons, the treatment table only moves if you press one of the buttons on the hand control or the optional foot control. When released, the movement is stopped immediately.
- 3. Never support, stand, or kneel on any part of the bed surface. Do not exert any strong physical force on the treatment table's surface. Otherwise you can permanently damage the upholstery of the 601. RISK OF DAMAGE!
- 4. Do not lean against the arm supports or the headrest! Never stand, sit, or kneel on the arm supports or the headrest. RISK OF DAMAGE!
- 5. The 601 is equipped with a locking function to protect against unauthorized use. The drive system locks automatically after 30 minutes of non-operation. The heating cycle currently in process is not affected by this. Manual locking also does not affect the heating cycle currently in process and has no effect on the operation of the heating system.
- 6. The maximum load capacity of the armrests is 25 kg.
- 7. The rating plate must never be made illegible or removed! Non-compliance will result in the exclusion of the warranty!

READ THIS INSTRUCTION MANUAL THOROUGHLY AND KEEP IT IN A SAFE PLACE FOR FUTURE REFERENCE.

2. Intended Use

- Read these instructions thoroughly.
 Only operate the treatment table in the intended use as described to protect your customers and yourself from danger.
- ◆ The 601 is a treatment table and **no** medical device.
- The 601 is a multi-functional treatment table which e.g. can be used for cosmetic applications, facial treatments, or all types of massages in dry environments. Any other use is not permitted and affects your warranty claims.
- The 601 is only intended for use in closed rooms with defined ambient conditions. See chapter 19. CONDITIONS OF TRANSPORT, STORAGE AND OPERATION.

★ No liability for personal injury or material damage will be accepted if these instructions are not followed.

3. Scope of delivery

- > 1 TREATMENT TABLE 601 in the desired design and equipment
- ▶ 1 HAND CONTROL
- ▶ 1 INSTRUCTION MANUAL
- If you have ordered additional optional accessories / further optional equipment for your treatment table at the time of purchase, this is also included in the scope of delivery.

4. Preliminary remarks

- The Gharieni treatment table 601 is subject to the highest safety and quality standards.
- Before first use, please check that all components are present and that they are not visibly damaged.
- Make sure that the socket for the treatment table is properly grounded and has the correct mains voltage and mains frequency, see rating plate.



Before setting up, make sure that there is enough space for the 601 so that it does not meet anything even when it is fully extended.

5. Delivery and unpacking

5.1 Delivery

- The 601 is delivered on a pallet in a cardboard box (s. fig. below). The 601 is completely horizontal and the upholstery is already in place.
- ① The legrest is in the lowest position.
- i The armrests are swiveled 180° and pushed completely towards the seat.
- The extendable footrests are in the box under the head end of the 601, on the pallet.
- The optionally available metal sheet as a privacy screen for treatments in the prone position is also in the box, the corresponding rail must be attached to the underside of the headrest using the screws provided. If you do not need the sheet, you can stow it using a second rail on the legrest.

DELIVERY BY GHARIENI GROUP GMBH:

If the delivery is handled by Gharieni Group GmbH, the delivery driver will help to set up the 601 and will also dispose of the packaging material and the pallet.

DELIVERY BY A SHIPPING COMPANY:

If a shipping company handles the delivery, usually the 601 will only be delivered (no help with the installation of the 601). In this case, you must dispose of the packaging material and the pallet on your own.

5.2 Unpacking

WARNING! When unpacking, make sure that the components of the packaging are out of reach of children and animals. RISK OF SUFFOCATION!

- I The 601 is delivered on a pallet in a box (s. fig.).
- **1** The legrest is in the lowest position.
- I The armrests are swiveled 180° and pushed completely towards the seat.
- The extendable footrests are in the box under the head end of the 601, on the pallet.
- The optionally available metal sheet as a privacy screen for treatments in the prone position is also in the box, the corresponding rail must be attached to the underside of the headrest using the screws provided.



- 1. Cut the packaging straps (A) with scissors and remove them.
- 2. Do <u>NOT</u> open the upper cardboard box (B), but carefully lift it as a whole and vertically from the 601 and the pallet (C). You will need two people for this (one person each on the short sides of the box) (D).
- 3. Dispose of the cardboard box properly.
- 4. You can now lift the 601 off the pallet (it is imperative that you follow the instructions in chapter 6.2 TRANSPORT).



6. Assembly and transport

6.1 Assembly

In case of delivery by Gharieni Group GmbH, the delivery driver will help to set up the 601 and will perform the assembly of the parts disassembled for shipment and positioning of the corresponding parts to make the 601 ready for use.

If the 601 is delivered by a shipping company, you must assemble these parts yourself (s. chapter 5.2 UNPACKING).

The armrests are swiveled 180° and pushed completely towards the seat.

Loosen the knurled screw on the underside of the armrests, pull the armrests out slightly and now swivel the armrests upwards.

Be sure to tighten the knurled screw again.

Before raising the legrest completely, please adjust the height of the 601 first to avoid a collision of the legrest with the pallet.

Now slide the extendable footrests into the corresponding mountings in the legrest of the 601; the footrests are in the box under the head end, on the pallet.

If you have ordered the optional metal sheet as a privacy screen for treatments in the prone position, this is in the same box.

The corresponding rail must be attached to the underside of the headrest using the screws provided. If you do not need the sheet, you can stow it using a second rail on the legrest.

Before setting up the 601, make sure that there is enough space for the 601 so that it does not meet anything even when it is fully extended.

WARNING! If the treatment table is equipped with the heating system,¹ the cables are located between the upholstery and the underframe. The upholstery may only be removed by persons authorized by the Gharieni Group GmbH.

6.2 Transport

- Always consider the dimensions of the 601 when transporting. Transporting the 601 can sometimes be severely affected by unsuitable ambient. Such unsuitable ambient conditions are, e.g., narrow doors, narrow corners behind doors, narrow corridors, narrow stairways, spiral staircases etc.
 Weight of the 601 is at least approx. 120 kg; the length ranges from 180 cm to 200 cm and width including upholstery; this limits maneuverability of the 601.
- The best way to carry the bed is to lift it by the base only, one person at each corner of the base. Remove the transport lock (2 straps / if available) before putting the bed into operation.
- Never lift the 601 by the seat / lying surface or the armrests during transport. Otherwise you can seriously damage the 601.
- The 601 can be carefully moved or transported on flat surfaces using the castors. Do not use the castors on uneven surfaces.

NOTICE! Always secure the optional castors immediately by locking them. RISK OF INJURY! RISK OF ROLLING AWAY!

DANGER! Never roll the 601 over the power cable. Otherwise you can permanently damage the power cable.

DANGER! The power cable must not be under the adjustable stands or under the castors of the 601. Otherwise they can crush the power cable or cause permanent damage. RISK OF ELECTRIC SHOCK!

WARNING! Do not move the 601 on the castors while there are people or loads on the 601. Otherwise you will damage the construction or substructure of the 601 and the castors. RISK OF INJURY! RISK OF DAMAGE

¹ Optional accessory

WARNING! The 601 must never (neither with nor without castors) be used to transport people or heavy loads. RISK OF INJURY! RISK OF DAMAGE!

3 <u>Before moving the 601</u>, roll up the power cable properly and store it so that it cannot be rolled over when moving the 601. Do not hold the castors in place until the 601 is in desired position and you have ensured that the power cable is not located under the 601 or under its stands or castors.

WARNING! RISK OF INJURY by pinching the toes / feet when moving the bed!

NOTICE! Make sure to lift the 601 vertically off the pallet.

Non-compliance with this instruction may seriously damage the stands or castors of the 601. RISK OF DAMAGE!

NOTICE! The special pallet on which the 601 is delivered has several round cut-outs (s. fig. below). On delivery, the adjustable stands of the 601 are placed in the respective cut-outs to prevent the wellness bed from moving. It is therefore essential that you lift the 601 <u>vertically</u> off the special pallet. Non-compliance with these instructions can seriously damage the stands or the optional castors of the 601. RISK OF DAMAGE!



Illustrations similar: all illustrations in this chapter serve as examples only.

NOTE! You need **4 persons** to lift the 601 off the pallet.

 To lift the 601 off the pallet, it must first be raised slightly so that the upholstery of the legrest does not collide with the edge of the pallet. To do this, first connect it to a suitable connection socket. Then press the corresponding button of the hand control and keep it pressed. The hand control is located on the side of a suspension device (button T1, see figure in chapter 11.1 HAND CONTROL).



2. You must also bring the backrest into an upright position before lifting the 601. To do this, press the corresponding button on the hand control and keep it pressed (**button T2**, see figure in chapter 11.1 HAND CONTROL).

3. Then pull the power supply plug !

4. Lift the 601 with one person at each corner of the base by hand <u>simultaneously</u>. You need four people to do this.


NOTICE! You must always lift the 601 with one person simultaneously at each corner of the base, otherwise you can seriously damage the bed. RISK OF DAMAGE!

- 5. You also need **four persons** to carry the 601 to the location you want.
- 6. Be sure to lift the 601 **vertically** off the pallet. Otherwise you will damage the stands or castors.
- 7. Carry the 601 by the base only. Otherwise you can irreparably damage the 601.
- 8. If the floor is not completely level, you must ensure the stability of the 601 by adjusting the four stands (B), (see figure).
- The treatment table is fully operational in just a few simple steps. It can be flexibly adapted to any body size. Depending on the purpose, you can set the desired position electrically in a very short time and then concentrate entirely on your customers.

ADJUSTABLE STANDS OF THE 601

Use the adjustable stands to properly align the 601. The 601 must be in a stable and level position for proper operation. In order that the 601 does not wobble, the 4 stands must stand firmly on the floor.

NOTICE! If the floor is not completely level, the stability may have to be adjusted to the floor by using the adjustable stands.

6.3 Space requirements


Before setting up, make sure that there is enough space for the 601 so that it does not meet anything even when it is fully extended.

7. Rating plate

- ★ The rating plate is located **at the head end** of the 601: on the wood panel underneath the backrest.
- 1. To gain access to the rating plate, you must place the backrest in an upright position (see figure below / **button T2** of the hand control, see fig. in chapter 11.1 HAND CONTROL).



2. The rating plate is located on the wooden covering (see figure).




- \star The first item on the rating plate is the serial number.
- The rating plate must never be removed or made illegible! Non-compliance will invalidate the warranty!


8. QR-Code



10.1 Characteristics

- The 601 is a versatile treatment table that you can use e.g. cosmetic applications or full body massages in dry rooms.
- The 601 is available in two upholstery variants (STANDARD and SOFT); see chapter 9. UPHOLSTERY.
- The entry height due to the SOFT and thicker upholstery is approx. +5 cm compared to the STANDARD upholstery.
- The 601 is also available in various upholstery widths (SMALL, MEDIUMSMALL, MEDIUM/ see chapter 10.2 MODEL VARIANTS).
- The Gharieni 601 is a treatment table with two lifting columns and two actuators (see chapter 10.2 MODEL VARIANTS) intended to adjust the table using a hand control or an optional foot control.
- Working height, backrest, inclination of the seat area and legrest are electrically adjustable. [The adjustment of the working height is achieved by synchronous movement of the lifting columns (front and rear lifting columns move), the adjustment of the seat inclination is achieved by asynchronous movement of the lifting columns (only the front lifting column moves), see chapter 11. ELECTRICAL ADJUSTMENTS.

- Frequently used treatment positions can be adjusted, stored, and recalled by two individual memory positions using the hand control or optional foot control (see chapter 11.7 MEMORY FUNCTIONS OF THE HAND CONTROL and chapter 12. FOOT CONTROL).
- The 601 is equipped with four pre-set positions which you can adjust using buttons P1 to P4.
- The optional armrests are pneumatically adjustable and swiveling; s. chapter 10.7.1 PNEUMATICALLY ADJUSTABLE ARMRESTS.
- The inclination of the headrest can be adjusted manually using a locking pin, the headrest is horizontally adjustable and completely removable using a rail (see chapter 10.6 HEADREST).
- In addition to the standard headrest, the 601 can be equipped with two other variants: the dual headrest with an exchangeable round or horn-shaped face support or the U-shaped headrest. (see chapter 17.1 HEADRESTS).
- \bullet The optional arm supports are extendable and can be rotated by 180°.
- When purchasing a 601, a hand control is always included as an adjustment control. Optionally, for an extra charge, a foot control can be purchased.
- The 601 is equipped with many adjustment options and can therefore be used for numerous applications.
- ◆ The maximum lifting capacity of the 601 is approx. 250 kg.
- ✤ The maximum load capacity of the treatment table's surface is approx. 300 kg.
- ◆ The maximum load capacity of the armrests is 25 kg.
- ✤ The maximum load capacity of the arm supports is 25 kg.

10.2 Model versions

- ➤ The treatment tables of the Gharieni 601 series are available in three different upholstery widths: SMALL 75 CM / MEDIUMSMALL 80 CM / MEDIUM 85 CM.
- The treatment tables of the Gharieni 601 series are equipped with two lifting columns and two actuators, with which you can adjust the treatment table using the hand control or the optional foot control.
- The non-actuator-operated areas (headrest / armrests) can be adjusted pneumatically or manually by operating a gas spring using a lever or manually using a knurled screw.

10.3 Before first use

10.5 Gas springs


- ✤ The armrests are adjusted with a gas spring (pneumatic).
- If you make an adjustment using the gas spring lever, you only need to operate the lever <u>when lowering</u> and press it down with your hand.
- To lift an armrest again, pull it upwards (without operating the corresponding lever).

10.6 Headrest

A WARNING! Never exert physical force on the headrest, regardless of the treatment table's surface setting. Non-compliance with these instructions can permanently damage the support structure. RISK OF TIPPING! RISK OF BREAKAGE! RISK OF INJURY!

- Use the locking pin to adjust the headrest, which is located under the headrest. Pull the locking pin and adjust the headrest. Make sure that the locking pin audibly engages again after setting.
- The inclination angle of the headrest is manually adjustable in five preset levels (+ 10°, 0°, -10°, -20°, 90°) (s. figures).
- The headrest can also be pulled out manually by a maximum of 7 cm and removed. The extension range of the headrest is limited to 7 cm via locking pin. To extend the headrest, loosen the knurled screw and pull out the headrest together with the mount as desired. Then tighten the knurled screw again. The locking pin is located on the backrest frame, below the locking pin for adjusting the inclination angle of the headrest (s. fig. 3).

NOTICE! Be sure to tighten the knurled screw again. Otherwise the headrest may fall out and damage the 601 and/or your customer may be injured! RISK OF DAMAGE! RISK OF INJURY!






- The upholstery of the standard headrest is equipped with a nose slit for back massages. For this purpose, this headrest is equipped with a separate upholstered part which can be removed (see fig. 4).
- ✤ The optionally available dual headrest also has a nose slit.
- The face of the person to be treated can also be supported by placing an optional face gel cushion (see fig. 5) available from Gharieni (see also chapter 17.9 GEL PAD FOR NOSE SLITS).

10.6.1 Headrest versions

- I Two additional headrests are optionally available for the 601, at an extra cost:
 - o a dual headrest (s. fig. 7)
 - this headrest has a round or a horn-shaped face support.
 - The scope of delivery of the dual headrest includes an air cushion with a hand pump, which allows individual adjustment of the height of the respective face supports (s. figs. 9, 10 and 11). The inflated air cushion allows the face support to flexibly adapt to the movements of your customer in all directions.
 - a U-shaped headrest (s. fig. 8 and chapter 10.6.2 INSTALLING THE U-SHAPED HEADREST).



- Both face supports of the dual headrest have a nose slit. To obtain the nose slit on the round face support, please remove the separate upholstery part.




10.6.2 Installing the U-shaped headrest

INSTALLING THE HEADREST

- 1. Slide the tubes of the headrest (1) into the corresponding mountings (1 a) on the backrest of the 601, s. fig. below
- 2. Lock the headrest in place with the fastening screw (1 b).
- 3. Then attach the cushion (2) to the frame of the headrest (1).

10.7 Armrests



10.7.1 Pneumatically adjustable armrests

- ✤ The armrests of the 601 can be lowered or raised individually using a gas spring ("HANDS FREE OPERATION" / see also chapter 10.5 GAS SPRINGS).
- By operating the lever on the respective side and by applying slight pressure, these can also be adjusted infinitely.
- The pneumatically adjustable armrests of the 601 can also be swiveled. To do this, pull the locking pin and push the armrests outwards. Move the armrests towards the bed until the locking pin snaps in place and you hear a click.
- ✤ Hence the bed is ideal for back massages (see fig. below).
- By swiveling the armrests, you can also move closer to the head of the person to be treated during cosmetic treatments or facial massages.

10.7.2 Additional locking mechanism of the armrests

- The armrests of the 601 can also be locked using a locking knob on the side of the bed (see fig.).
- This additional locking ensures increased stability and safety of the armrests and should be done after each treatment.

- 1. To lock the armrests, **push the inner red knob inwards**.
- 2. The armrests are now locked.



10.8 Arm supports

- The arm supports (see figure in chapter 10.4 VIEW) are always parallel to the seat.
- For lateral access and for treatments in the massage position (prone position) they can also be swiveled down by 180°; see illustration.
- ✤ They can also be pulled out manually.

To swivel the arm supports, proceed step by step as follows:

- Loosen the knurled screw underneath the arm support.
- Pull out the arm support to the side so that the arm support cannot collide with the seat when swiveling.
- Swivel the arm support backwards, respectively downwards by applying gentle pressure.
- Slide the arm support back up to the bed.
- Tighten the knurled screw.
- > The arm supports are optionally available.

NOTICE! Make sure to pull out the arm supports using the knurled screw before swivelling them; otherwise you may permanently damage the upholstery of the bed! RISK OF DAMAGE!

- With the footrests and headrest pushed in, the length of the lying surface is approx. 180 cm.

11.1 Hand control

The hand control is a wired control.

It enables the electrically controllable functions to operated.


- Saving certain lying positions is described in chapter 11.7 MEMORY FUNCTIONS OF THE HAND CONTROL.
- You can control the two lifting columns and the two actuators by pressing and holding down the corresponding button.
- Furthermore, you can individually adjust, save, and recall two memory positions.
- ◆ It is also possible to recall the four pre-set positions P1 P4.
- The hand control has 12 buttons.
- When not in use, the hand control can be stored underneath the seat, behind the armrest mount, on a holder.
- The adjustment of the working height, the backrest, the inclination of the seat area, and the legrest (buttons T 1 T 4 on the hand control or on the optional foot control) is done by a double-tap system.
- This is for safety reasons.
 A movement that is associated with danger is made <u>consciously</u> by this.

For the direction of movement, please note the arrow symbols and the number of dots in the upper area of the hand control.

By <u>simply</u> pressing a button and keeping it pressed, a movement is made upwards.

By pressing a button <u>twice</u> (double-tap system) and keeping it pressed, a movement is made in the opposite direction.

Storing the two individually adjustable memory positions and de-activation of the locking function is also done using the double-tap system.

11.2 Adjustment of the working height

- Use button **T1** to adjust the WORKING HEIGHT; s. fig. in chapter 11.1 HAND CONTROL.
- For the direction of movement, please note the arrow symbols and the number of points above on the hand control.
- Press the button once and keep it pressed to raise the 601.
 Press and the button <u>twice</u> (double-tap system) and keep it pressed to lower it.
- The horizontal WORKING HEIGHT of the 601 can be adjusted from approx. 59 cm to approx. 99 cm (with the stands screwed in).
- The horizontal WORKING HEIGHT of the 601 with soft upholstery can be adjusted from approx. 64 cm to approx. 104 cm due to the slightly thicker upholstery (with the stands screwed).
- By unscrewing the stands (up to approx. 3 cm) you raise the working height somewhat.
- By using the optionally available lockable castors, you raise the working height by approx. 5.5 cm.
- The ENTRY HEIGHT is the lowest setting of the seat. This is indicated in the horizontal position of the seat.
 - ▶ <u>601 (standard upholstery)</u> = approx. 59 cm / seat in horizontal position
 - \blacktriangleright <u>601 (soft upholstery)</u> = approx. 64 cm / seat in horizontal position

To recall the fixed entry position, press program button **P1** on the hand control and keep it pressed **until** the entry position is reached.

11.3 Adjustment of the backrest

- ✤ The inclination of the backrest can also be adjusted by using the hand control.
- ✤ Use the corresponding button (T 2) to adjust the BACKREST; s. fig. in chapter 11.1 HAND CONTROL.
- For the direction of movement, please note the arrow symbols and the number of points above on the hand control.
- Press the button once and keep it pressed to raise the backrest.
 Press the button twice (double-tap system) and keep it pressed to lower the backrest.

WARNING! When setting the treatment position, make sure that there are no body parts, objects, or persons between the bed components. RISK OF CRUSHING!

11.4 Adjustment of the inclination of the seat area

- The inclination of the seat area of the 601 can also be adjusted using the hand control.
- ✤ Use the corresponding button (T 3) to adjust the inclination of the seat area (s. fig. in chapter 11.1 HAND CONTROL resp. fig. in chapter 12. FOOT CONTROL).
- For the direction of movement, please note the arrow symbols and the number of points above on the hand control.
- Press the button once and hold it down each time to adjust the inclination of the seat area or twice (double-tap system) to adjust the seat area horizontally.

11.5 Adjustment of the legrest

- The inclination of the legrest can also be adjusted by using the hand control. The seat area must be raised for this purpose (see chapter 11.4 ADJUSTMENT OF THE INCLINATION OF THE SEAT AREA).
- ✤ Use the corresponding button (T 4) to adjust the legrest (s. fig. in chapter 11.1 HAND CONTROL).
- For the direction of movement, please note the arrow symbols and the number of points above on the hand control.
- Press the button once and keep it pressed to raise the legrest.
 Press the button twice (double-tap system) and keep it pressed to lower the legrest.

11.6 Locking function / locking button of the hand control

- The 601 is equipped with a LOCKING FUNCTION to protect against unauthorized use. The drive system itself locks automatically after 30 minutes of inactivity. The current heating cycle is not affected.
- Manual locking also does not affect the heating cycle currently running and does not affect the operation of the heating system.

ACTIVATION OF THE LOCKING FUNCTION:

- To activate the locking function, press the LOCK button (**T 11**) on the hand control and **hold it down** for approx. 3 seconds.
- 2. The backlighting of the hand control increases in intensity. **For confirmation**, the LED above the button of the hand control lights up.
- 3. The drives are now locked.

DE-ACTIVATION OF THE LOCKING FUNCTION:

- 1. To release, press the LOCK button (**T 11**) on the hand control **twice in quick succession** and **hold it down** for approx. 3 seconds.
- 2. The backlighting of the hand control will now dim slightly.
- 3. The drives are now unlocked.

NOTICE! To prevent unauthorized use of the 601, always activate the locking function when leaving the treatment room. If you should forget to do this, the drives lock automatically after 30 minutes.





11.7 Memory functions of the hand control

- In addition to four pre-set treatment positions, the hand control of the 601 has two individually adjustable and storable positions (memory positions: M 1 / M 2).
- The memory function saves the treatment positions you have selected, thus simplifying your workflows. Use buttons M1 and M2 (see fig. in chapter 11.1 HAND CONTROL).
- Memory positions are stored in the same way as the electrical settings of the 601 using a double-tap system.

SAVING MEMORY POSITIONS M1 & M2:

- 1. Set the desired position as usual with buttons T1 to T4.
- 2. Press button M1 or M2 (double-tap system) and keep it pressed for three seconds.
- 3. An acoustic signal sounds when the storage has been successful. The respective memory position is now stored.

RECALLING MEMORY POSITIONS:

Press and keep the corresponding MEMORY button M1 or M2 pressed until the stored treatment position is reached.



12. Foot control with Bluetooth (optional equipment)

- ✤ A foot control with Bluetooth can be connected as an option in addition to the hand control.
- The foot control enables the adjustment of the basic functions, the approach of two permanently stored positions as well as the storage and recall of two individually adjusted memory positions.

In addition, the heating system can be operated, the bed can be locked and unlocked, and the bed software can be reset.

The operation is done in the double-tap system, as with the hand control. This is for safety reasons. A movement that is associated with danger is made <u>consciously</u> by this.

For the direction of movement, please note the arrow symbols and the number of dots on the foot control.


By simply pressing a button and keeping it pressed, a movement is made upwards.

Pressing a button twice (double-tap system) and keeping it pressed makes a movement in the opposite direction.

The two individually adjustable and storable memory positions are also stored using the double-tap system.

When purchasing a 601, the hand control is included as standard. Optionally, for an additional charge, the foot control can be purchased.

NOTICE! Due to the surface material of the foot control, it may need to be cleaned with an alcohol-free cleaning agent on a soft cloth or paper towel. **Never** use hard sponges, pot cleaners, scouring cloths or aggressive cleaning agents such as scouring powder. Dishwashing detergent, solvents, bleach, or essential oils must also **not be used** to clean the foot control. RISK OF DAMAGE!

12.1 LED module

When operating the optionally available heating system with the optionally available foot control with Bluetooth, the respectively set heating level is displayed with a LED module, see table and figure below.

The LED module has three rows of LEDs.

The LED module is located on the back of the treatment table, on the wooden paneling below the backrest.

The heating level set at any given time can be easily recognized with the LED module and saves a look at the hand control.

13. Heating system (optional equipment)

- The upholstery surface of the 601 can be heated to increase comfort. It is a pre-programmed and fully automatic heating system which allows comfortable operation. This heating system is integrated in the upholstery of the treatment table and works with modern microprocessor technology. For the 601, the heating system is optionally available at extra cost.
- Due to the pre-programmed microchip, you only must switch on the heating system to start the heating system with the lowest heat / power level. To quickly heat up the bed's surface before starting treatment, we recommend setting the heating system to level 3 (highest level). The heating program is fully automated and switches off automatically after a total time of 90 minutes.
 - ▶ s. chapter 13.1 OPERATION.
- The drive system locks automatically after 30 minutes of inactivity. The heating cycle currently in process is **not affected** by this.
- Even a manual locking does not affect the heating cycle currently in process and has no effect on the operation of the heating system either.
 - ➤ s. chapter 11.6 LOCKING FUNCTION / LOCKING BUTTON OF THE HAND CONTROL.

▲ **CAUTION!** If your 601 is equipped with the optionally available heating system, do not place heavy blankets, clothing or similar on the upholstery while the heating system is switched on. RISK OF DAMAGE! RISK OF BURNS!

NOTICE! The currently active heating level is visualized via an LED (diode) in the middle of the upper section of the hand control. The frequency of the impulse for visualization varies accordingly.

- 1. **Do not** use the heating system in the following cases:
 - > on customers with pacemakers.
 - > on pregnant women.
 - > on customers with thrombosis.
 - > on customers suffering from pain of unknown cause.
- 2. Use only on healthy people.
- 3. If treatment is terminated prematurely, the heating system must be switched off by pressing the corresponding button on the hand control resp. on the optional foot control to prevent heat accumulation.
- 4. Disconnect the 601 from the mains if it is not used for a longer time, e.g. overnight.

WARNING! People with acute pain, venous disorders, low blood pressure, inflammatory processes and other medical conditions that make heat applications or this form of client positioning questionable **must** always consult a doctor before use.

WARNING! Never use the 601 and / or the heating system on people who are under the influence of alcohol or drugs.

WARNING! If the treatment table is equipped with the heating system (optional), the cables are located between the upholstery and the underframe. The upholstery may only be removed by persons authorized by the Gharieni Group GmbH.

13.1 Operation

- The heating system is operated using the button (T 12) of the hand control.
- ✤ For operation with the optional foot control see chapter 12. FOOT CONTROL WITH BLUETOOTH (OPTIONAL EQUIPMENT).



POWER ON:

• Use this button to switch **on** the heating system.

The heating system comes with three heat / power levels. To quickly heat up the bed's surface before starting treatment, we recommend setting the heating system to level 2; only in exceptional cases to level 3 (highest level).

Please refer to the chart below to find information on how to operate the heating system.

After a total time of **90 minutes** the heating system shuts down **automatically**; regardless of the set heating level.

✤ This process is pre-programmed.

POWER OFF:

• Using this button you also switch **off** the heating system.

NOTICE! If your 601 is equipped with the optionally available heating system and the optionally available foot control with Bluetooth, the heating level currently set is displayed additionally with the LED module (s. chapter 12.1 LED MODULE).

14. Reset

I You can reset the software of the bed to its initial state; e.g. for the complete reprogramming of treatment positions etc.

PLEASE PROCEED AS FOLLOWS:


- 1. Press buttons **T** 11 and **T** 12 of the hand control <u>simultaneously</u> and keep them pressed for approx. 3 seconds until a successful reset process is indicated by the LED in the upper area of the hand control flashing three times (= reset / s. fig. 16).
- 2. The software is reset to its initial state.
- The LED (diode) in the upper area of the hand control **flashes three times** to visually **confirm** a successful reset process.

<u>OR</u>

- Press and hold the buttons T 8 and T 9 of the foot control (see below, fig. 17) simultaneously for approx. 3 seconds until a successful reset process is indicated by the LED in the upper area of the foot control flashing three times.
- 2. The software is reset to its initial state.
 - The LED (diode) in the upper area of the hand control **flashes three times** to visually **confirm** a successful reset process.
 - **I** Stored memory positions are deleted.

NOTICE! Always wait until the hand control signals a successful reset process by flashing the LED three times. Otherwise the reset process is not completed!

NOTICE! If your treatment table is equipped with the optionally available heating system and with the optionally available foot control, a successful reset process is signaled by all three rows of the LED module flashing three times.

WARNING! Always ensure that water or other liquids **never** enter the housing and fittings of the 601 or the hand control. RISK OF ELECTRIC SHOCK! FIRE HAZARD!

NOTICE! Damage to the bed, the upholstery and / or the material of the base / support structure caused by use of unsuitable cleaning agents **is not covered by the warranty!**

- Before performing any cleaning or maintenance work on the 601, please remove all hand and arm jewellery (rings, bracelets etc.).
 Otherwise you could accidentally scratch and / or damage the upholstery and / or the material of the base.
- Use only water or a mild cleaning agent suitable for the respective material.
- *** Do not** use hot water to clean the 601.
- * Never use hard sponges, pot cleaners or abrasive cloths.
- * Never use aggressive cleaning agents such as scouring powder, floor cleaner etc.
- **Never** use dish detergent.
- **Never** use solvents or bleach.
- ✤ Never use essential oils for cleaning.

16.1 Cleaning the PU upholstery

Clean the PU only with a soft cloth with a small amount <u>of a detergent</u> <u>suitable for this material</u> (also available from Gharieni: see chapter 18. UPHOLSTERY CARE AND CLEANING AGENTS).

16.2 Cleaning and care of the Ferrari Stamskin

Clean the artificial leather only with a soft cloth with a small amount of a detergent suitable for this material (also available from Gharieni: see chapter 18. UPHOLSTERY CARE AND CLEANING AGENTS).

NOTICE! The upholstery of the 601 can also be Ferrari Stamskin Top. This material can be cleaned with a cloth with some detergent, which must be suitable for this material.

16.3 Cleaning the housing and the fittings

Clean the housing and the fittings only with a soft cloth with a small amount of a detergent suitable for this material (also available from Gharieni: see chapter 18. UPHOLSTERY CARE AND CLEANING AGENTS).

WARNING! Always make sure that water or other liquids **never** enter the housing, fittings, or the hand control of the 601. RISK OF ELECTRIC SHOCK! FIRE HAZARD!
