1.2 Signal words

▲ DANGER! indicates a hazardous situation which, if ignored, will result in death or serious injury.

⚠ CAUTION! indicates a hazardous situation which, if not avoided, may result in minor or moderate injury.

⚠ **WARNING!** indicates a hazardous situation which, if ignored, could result in death or serious injury.

NOTICE! indicates a hazardous situation which, if ignored, may result in damage to the spa table / appliance.

1.3 Safety instructions

△ DANGER!

To reduce the risk of electrocution:

- Non-compliance of the orders of this instruction manual will endanger the life and health of the operator and / or can result in damages to the Spa Table.
- 2. All electrical work to connect the MLW to the mains must be carried out by a qualified professional. Do not modify the energy supply. The connection must be carried out in accordance with the current local and legal regulations. RISK OF ELECTRIC SHOCK!
- 3. The technical data of your energy supplier **must** meet the data on the rating plate of the MLW.
- 4. Do not make any changes or manipulations to the 601 and / or its power supply (mains cable, mains plug). In case of unauthorised changes or manipulations, **any** warranty of the manufacturer is excluded.
- 5. **Do not connect** the MLW to the mains if the Spa Table itself or the power cable or the plug are visibly damaged. RISK OF ELECTRIC SHOCK!
- 6. The power supply cable shall not be placed below the MLW, except it is expressly permitted by the manufacturer. RISK OF ELECTRIC SHOCK!
- 7. The power cord must not be placed close to the actuators during connection or repositioning as it can be damaged while operating the actuators. RISK OF ELECTRIC SHOCK!
- 8. Never roll the MLW over the power cord; otherwise you can damage the power cord permanently.


- 9. When retracting the castors, the power cord must not be under the MLW; otherwise, the adjustable feet may squeeze the power cord and cause permanent damage. RISK OF ELECTRIC SHOCK!
- 10. Never try to repair the MLW yourself. If the MLW does not operate properly, please contact the manufacturer or the shop you purchased the MLW at. Original spare parts should be used only.
- 11. If the power cable and / or the plug are damaged, it **must** be replaced by the manufacturer or an authorized aftersales service or a qualified professional only. **Never** try to repair or replace the power cable and / or the plug yourself. RISK OF ELECTRIC SHOCK!
- 12. **Always** unplug the MLW if it is not used for a longer period.
- 13. Always disconnect the MLW from the mains before cleaning and / or maintenance. RIKS OF ELECTRIC SHOCK!
- 14. **Never** pull the power supply cable to unplug the MLW. Always use the power plug itself to unplug the MLW. RISK OF ELECTRIC SHOCK!
- 15. **Never** touch the power plug, the power switch, or other electrical components with wet or damp hands. RISK OF ELECTRIC SHOCK!
- 16. Do not place or store the MLW close to a bath, a shower, or a washbasin. There is danger that the MLW may meet splashed water. RISK OF ELECTRIC SHOCK!

- 8. Liquids **must not** get into the electric control panels! RISK OF ELECTRIC SHOCK!
- 9. Do not use water or any other liquids while carrying out any application. Do not spill water or any other liquids over, on or into the MLW. Should you spill any water, **immediately** pull the mains plug and dry the MLW thoroughly. RISK OF ELECTRIC SHOCK!
- 10. **Never** immerse any parts of the MLW in water. When cleaning the MLW, make sure that no water penetrates the MLW or its housing. RISK OF ELECTRIC SHOCK!
- 11. For models with the Smart Thermo heating system and / or the Vibro Wellness 10 function, the cables are located between the upholstery and the base (depending on the model). **The upholstery may only be removed by persons authorised by us.**
- 12. For MLW F1 Soft only: To prevent damage caused by heat, a gap must be left between the backrest and the seat upholstery (see illustration below) when the heating system (optional equipment) is used for longer periods, so that the two heating elements do not touch each other and can add up. RISK OF BURNS DUE TO HEAT ACCUMULATION!



- 13. People with acute pain, venous disorders, low blood pressure, inflammatory processes and other medical conditions that make heat applications or this form of client positioning questionable must always consult a doctor before use.
- 14. Never use the 601 on people who are under the influence of alcohol or drugs.
- 15. Operate or store the MLW in a dry environment only.
- 16. Close supervision is necessary when the MLW is used by, on, or near children or invalids.
- 17. Use the MLW only for its intended use as described in this manual. Do not use attachments / accessories not recommended by the manufacturer.

- 18. Never operate the MLW if it has a damaged cord or plug, if it is not working properly, if it has been damaged or if it has become wet. Return the MLW to an authorized aftersales service for examination and repair.
- 19. Remove possible dust accumulation at the power plug, at the safety power socket and at all plug connectors **regularly**. RISK OF FIRE!
- 20. Keep the cord away from heated surfaces.
- 21. Never drop or insert any object into any opening.
- 22. Do not use the MLW outdoors.
- 23. Do not allow any unauthorized person to operate the MLW!
- 24. Use the MLW only on a level surface.
- 25. **Do not place** any objects or liquids on the MLW. The Spa Table as well as the material can be damaged thereby. RISK OF ELECTRIC SHOCK! RISK OF DAMAGE!
- 26. Any repairs and maintenance work must be carried out by qualified professionals authorized by the Gharieni Group GmbH **only**! RISK OF ELECTRIC SHOCK! RISK OF FIRE!
- 27. **Do not use** a steam cleaner for cleaning. RISK OF ELECTRIC SHOCK!
- 28. **Never** rest or stand on any part of the lying surface or of the supporting structure of the MLW. Do not exert strong physical forces on these components; otherwise you can damage the supporting structure permanently. RISK OF TIPPING! RISK OF BREAKAGE! RISK OF INJURY!
- 29. Persons, animals or body parts of persons and animals **must not** be positioned between the base and the upper structure. RISK OF CRUSHING!
- 30. Ensure that no parts of the body or items are between the parts of the MLW while adjusting the lying position. RISK OF CRUSHING!
- 31. **Do not** use the supporting structure as a footrest. RISK OF CRUSHING!
- 32. Always ensure that the MLW stands on its solid adjustable feet. If the MLW stands on its mobile castors only, there is a RISK OF ROLLING AWAY!
- 33. **Never** extend the castors while any person is on the MLW. Do not move the MLW on its castors if any person or load is on the MLW; otherwise you damage the substructure or castors.
- 34. The MLW must **never** be used (neither with nor without castors) for to transport persons or heavy loads. RISK OF INJURY! RISK OF DAMAGE!
- 35. While unpacking, the packaging materials (polyethylene bags, polystyrene pieces, etc.) should be kept away from children and pets. RISK OF INJURY! CHOKING HAZARD!

- 36. Always keep children and pets away from the MLW.
- 37. Children must not play with the MLW or its single components.
- 38. The MLW is not intended to be operated by persons with reduced physical, sensory, and mental capabilities or lack of experience or knowledge, unless they are supervised or instructed concerning the use of the MLW and do understand the danger resulting thereof.

NOTICE!

- 1. The special pallet the MLW is delivered on has cut-outs. Upon delivery, the adjustable feet of the MLW stand in the respective cut-outs to prevent the Spa Table from inadvertent movement. Therefore, it is essential to lift the MLW <u>vertically</u> off the special pallet using all four special carrying aids. Non-compliance with this instruction can damage the adjustable feet of the MLW seriously. RISK OF DAMAGE!
- 2. For safety reasons, the MLW moves only while pressing a button of the hand controls or the optional foot control. When you stop pressing, all moving operation will stop immediately.
- 3. **Never** rest, stand, or kneel on any part of the lying surface of the MLW. Do not exert strong physical forces on the lying surface; otherwise you can damage the upholstery permanently. RISK OF DAMAGE!
- 4. Do not lean, stand, or sit on the armrests or headrest; otherwise you can damage the armrests or headrest permanently! RISK OF DAMAGE!
- 5. The maximum load capacity of the armrests is 25 kg.
- 6. The rating plate must not be removed or made illegible.

Non-compliance will expire the warranty!

READ THESE INSTRUCTIONS THOROUGLY AND KEEP THEM SAFE.

2. Intended use

- * Read the instructions very carefully and **only** operate the Spa Table in its intended use as described to protect you and your customers from danger.
- ❖ The MLW is a versatile Spa Table. You can use it for e.g. cosmetic applications or full body massages in dry rooms, etc.
 - Any other use is not permitted and will affect the warranty claims.
- ❖ The Gharieni Spa Table MLW is not a medical device relevant to the medical devices act.
- ❖ The MLW is intended for indoor use **only**.
- ★ No liability for personal injury or material damage will be accepted if these instructions are not followed.

3. Scope of delivery

- ➤ 1 SPA TABLE MLW F1 WOOD / MLW F1 SOFT in desired design and equipment incl. rating plate and QR-Code.
- ➤ 1 HAND CONTROL
- ➤ 4 CARRYING AIDS
- ➤ 1 INSTRUCTION MANUAL
- If you have purchased additional optional accessories for your Spa Table, these are also included in the scope of delivery.

4. Preliminary remarks

- ❖ The Gharieni Spa Table MLW is subject to the highest safety and quality standards.
- Before initial operation, make sure that all parts are present and show no visible damage.
- Make sure that the socket for the MLW is properly grounded and has the correct voltage rating.



Before assembly, ensure that sufficient space is provided for the MLW so that it does not bump into anything even when fully extended.

5. Delivery and unpacking of the MLW

5.1 Delivery

The MLW is delivered and packed in a cardboard on a special pallet (s. fig. below). The MLW is in complete horizontal position and the upholstery is installed.



DELIVERY BY GHARIENI GROUP GMBH:

If the MLW is delivered by Gharieni Group GmbH, the driver will **help** with the installation of the MLW and will also dispose of the packaging material and the special pallet.


DELIVERY BY AN EXTERNAL FORWARDER:

If the MLW is delivered by an external forwarder, the MLW is normally **only** delivered. In this case, you must dispose of the packaging material and the special pallet on your own responsibility.

5.2 Unpacking

⚠ **WARNING!** While unpacking, the packaging materials (polyethylene bags, polystyrene pieces, etc.) should be kept away from children and pets. RISK OF INJURY! CHOKING HAZARD!

The MLW is delivered and packed in a cardboard on a special pallet (s. fig. below).

- 1. Cut the packaging tapes (A) with scissors and remove them.
- 2. **Do Not open** the upper cardboard (**B**) **but** lift it carefully and vertically as a whole from the MLW and from the special pallet (**C**). For this purpose, you will need two persons (one person each on the short sides / **D** of the cardboard).
- 3. Dispose of the cardboard properly.
- 4. Now you can move the MLW from the special pallet; **strictly observe** the instructions given in chapter 6.2 TRANSPORT / CARRYING AIDS and chapter 6.2.1 USE OF THE CARRYING AIDS when doing so.

6. Assembly and transport of the MLW

6.1 Assembly

The MLW is usually delivered fully assembled, so no assembly work is necessary. In **exceptional cases**, necessary assembly work will be carried out by the deliverer on site.

Before installation, ensure that there is sufficient free space for the MLW relevant to its total length.

⚠ WARNING! For models with the Smart Thermo heating system and / or the 10 Vibro Wellness function, the cables are located between the upholstery and the base (depending on the model). The upholstery may only be removed by persons authorised by us.

6.2 Transport

A transport of the MLW can be severely affected to some extent due to unfavourable environment conditions. Such unfavourable environmental conditions are e.g. narrow doors, narrow corners behind doors, narrow corridors, narrow staircases, spiral staircases etc. The weight of the MLW is at least 125 kg; the length is approx. 203 cm and the width including the upholstery is 76 cm / 85 cm or 92 cm¹; thus, the manoeuvrability of the MLW is limited.

EXTENDABLE / RETRACTABLE CASTORS:

- ❖ The MLW is equipped with extendable / retractable castors. The castors can be extended to change the site of the MLW (s. chapter 6.2.2 EXTENDABLE / RETRACTABLE CASTORS).
- If the floor conditions are not ideal, e.g. a wavy, uneven floor or a tiled floor with wide and deep joints, the MLW must not be moved on the extendable castors, otherwise it can be seriously damaged. In this case, you must use the CARRYING AIDS supplied (s. fig. below).

CARRYING AIDS:

- You also need the carrying aids (s. fig. above) to lift the MLW off the special pallet. The proper use of the carrying aids is described below in chapter 6.2.1.
- **You need 4 persons** to move or transport the MLW using the carrying aids.

6.2.1 Use of the carrying aids

▲ DANGER! After transport, while putting down the MLW, the power cord must not be under the Spa Table; otherwise the adjustable feet may squeeze the power cord and cause permanent damage while putting down the MLW or when retracting the castors.

⚠ **WARNING!** RISK OF CRUSHING your toes / feet while lowering or moving the MLW.

NOTICE! The special pallet the MLW is delivered on has recesses. Upon delivery, the adjustable feet of the MLW stand in the respective recesses to prevent the Spa Table from slipping. **Therefore, it is essential to lift the MLW vertically off the special pallet** using all four carrying aids. Non-compliance with this instruction can seriously damage the adjustable feet of the MLW. RISK OF DAMAGE!



Figures similar: All following figures serve as examples only.

1. To move the MLW from the special pallet, you must raise it first. Plug in the MLW to do this. Then press the corresponding button of the hand control which is on one side on a suspension mechanism / button T 1, s. fig. in chapter 11.1 HAND CONTROL.



2. You must set the backrest in upright position before you use the special carrying aids. To do this, press the corresponding push button of the hand control (**button A**, s. fig. in chapter 11.1 HAND CONTROL.

3. Then unplug the MLW again.

4. Lift the lower casing (**A**) by hand (s. fig. below) at the head and foot ends simultaneously by hand until the opening for the carrying aids become visible. You need to persons for this (one person at the head end and one person and the foot end of the spa table).






A LOWER CASING

NOTICE! You must **always** lift the casing of the spa table with one person at the head end and one person at the foot end **at the same time**, otherwise you can seriously damage the spa table. RISK OF DAMAGE!

5. Two more people can now insert the carrying aids (**C**) into the openings (**B**) provided for them in the feet (2 carrying aids at the head end / 2 carrying aids at the foot end of the spa table); s. fig. below.




В	OPENINGS PROVIDED FOR THE CARRYING AIDS

- 6. You also need **four persons** to carry the MLW to the area you want.
- 7. Make sure to lift the MLW (using **all four** carrying aids) **vertically** off the special pallet. Otherwise you will damage the feet.

- 8. **Only** carry the MLW using **all four** carrying aids; otherwise you may damage the MLW irreparably.
- 9. Keep the carrying aids in a safe place. If the MLW needs to be carried later (e.g. when moving to a new house), this can only be done using the carrying aids.
- 10. If the floor is not completely level, you must ensure the stability of the MLW by adjusting the four feet (**D**), s. fig. below.

 After adjusting the feet, secure them by tightening the respective lock nut (**E**), s. fig. below.

NOTICE! Once you have found a suitable place with enough space for the spa table, remove the carrying aids and store them well for possible later transport!

NOTICE! If the floor is not completely level, you must ensure the stability of the MLW by adjusting the four feet.

6.2.2 Extendable / retractable castors

△ DANGER! When retracting the castors, the power cord must not be under the MLW; otherwise, the adjustable feet may squeeze the power cord and cause permanent damage. RISK OF ELECTRIC SHOCK!

<u>A DANGER!</u> Never roll the MLW over the power cord; otherwise you can damage the power cord permanently.

⚠ **WARNING!** Always ensure that the MLW stands on its solid adjustable feet. If the MLW stands on its adjustable castors only, there is a RISK OF ROLLING AWAY!

⚠ **WARNING!** RISK OF CRUSHING your toes / feet while lowering or moving the MLW.

⚠ WARNING! Never extend the castors while any person is on the MLW.


⚠ WARNING! Do not move the MLW on its castors if there are persons or loads on the MLW; otherwise you will damage the construction / substructure of the MLW as well as its castors.

RISK OF INJURY! RISK OF DAMAGE!

⚠ WARNING! The MLW must never be used (neither with nor without castors) for carrying or transporting persons or heavy loads. RISK OF INJURY! RISK OF DAMAGE!


USE OF THE MECHANICALLY EXTENDABLE CASTORS:


- * The lever to mechanically extend the castors is located inside the housing at the foot end of the spa table below the legrest.
- 1. To gain access to the lever, you must raise the legrest (**A**), **button D** of the hand control / s. fig. in chapter 11.1 HAND CONTROL and see also chapter 11.5 ADJUSTMENT OF THE LEGREST.
- In addition, extend the inclination of the seat area (**button C**, s.fig. in chapter 11.1 HAND CONTROL) to gain even better access to the lever.

2. At the bottom of the now open housing (**B**) is the lever (**C**) for mechanical extension of the castors; s. fig. below.

- 3. Pull the lever **(B) towards you** to extend the castors. You must overcome an obstruction point.
- 4. The castors are now extended.
- **Before moving the MLW**, roll up the power cord properly and store it so that it cannot be rolled over when moving the MLW. Do not retract the castors until the MLW is in the desired area and you have ensured that the power cord is not under the MLW or under the feet.
- 5. Now you can roll the MLW to another position. Be careful not to damage the power cord!
- 6. Proceed in reverse order to retract the castors.

7. Rating plate

- The rating plate is in the housing at the head end of the MLW: on the construction below the headrest and backrest.
- 1. To gain access to the RATING PLATE, you must place the backrest in an upright position (s. fig. below / **button B** of the hand control, s. fig. in chapter 11.1 HAND CONTROL).

If you wish to contact the Gharieni customer service regarding your Spa Table, we recommend taking a photo of the rating plate previously (e.g. using a mobile phone or a digital camera). This makes it easier for you to identify the information of the rating plate (e.g. the serial number of the Spa Table) to provide the required information to the customer service. On the cover page of this instruction manual is an empty field in which you can enter the serial number of your Spa Table. This way you have the serial number always at hand.



- ❖ The QR code is located on the head side of the MLW: on the construction below the headrest and backrest.
- To gain access to the QR-CODE, you must place the backrest in an upright position (s. fig. below / **button B** of the hand control / s. fig. in chapter 11.1 HAND CONTROL).



- ❖ The MLW is available in **two** upholstery variants (MLW F1 Wood = standard upholstery / MLW F1 Soft = soft upholstery; s. below).
- The upholstery of the MLW F1 is available with an outer material made of polyurethane (PU).

10.1 Characteristics

- * The MLW is a versatile Spa Table. You can use it for e.g. cosmetic applications or full body massages in dry rooms.
- ❖ The MLW has a narrow housing (57 cm) and specially curved front sides. These features allow more foot and leg room and thus make it easier for you to work during massages and cosmetic treatment.
- ❖ The MLW F1 is available in two upholstery versions (MLW F1 Wood / MLW F1 Soft); s. chapter 9. UPHOLSTERY.
- ❖ The entry height of the MLW F1 Soft is approx. +5 cm compared to the MLW F1 Wood due to the thicker upholstery.
- The MLW F1 is also available in different widths (SMALL, MEDIUM, LARGE / s. chapter 10.2 MODEL VERSIONS).
- The Gharieni MLW F1 is a spa table that can be equipped with up to six actuators (s. chapter 10.2 MODEL VERSIONS), with which you can flexibly adjust the spa table to your wishes via hand control.
- ❖ MODELS WITH FOUR ACTUATORS: Working height, backrest, inclination of the seat area and legrest are electrically adjustable: the inclination of the seat area can be adjusted by the electrically adjustable knee bend (s. chapter 11. ELECTRICAL ADJUSTMENTS).
- * MODELS WITH SIX ACTUATORS: Working height, backrest, inclination of the seat area and the armrests are electrically adjustable (optional equipment).
- ❖ Frequently used treatment positions can be saved by eight freely selectable memory positions on the hand control (s. chapter 11.1.2 MEMORY FUNCTIONS OF THE HAND CONTROL).
- ❖ The armrests can be adjusted and swiveled pneumatically; s. chapter 10.7.1 PNEUMATICALLY ADJUSTABLE ARMRESTS.
- Lectrically adjustable armrests (non-swiveling) are also available as an option for the MLW, s. chapter 10.7.2 ELECTRICALLY ADJUSTABLE ARMRESTS (OPTIONAL EQUIPMENT).
- ❖ The headrest is pneumatically adjustable (s. chapter 10.6 HEADREST).

- ❖ Three adjustment controls are available when purchasing an MLW F1: hand control, remote control, or foot control. Only one of these is included in the delivery; the other two can be purchased at extra charge.
- ❖ The MLW has a wide range of adjustment options and can therefore be used for many applications.
- ❖ The maximum lifting capacity of the mlw is 250 kg.
- ❖ The maximum load capacity of the lying surface is 300 kg.
- ❖ The maximum load capacity of the armrests is 25 kg.

10.2 Model versions

❖ The Spa Tables of the Gharieni MLW Neo series are available in three different widths: SMALL 76 CM / MEDIUM 85 CM / LARGE 92 CM.

- ❖ The spa tables of the MLW F1 series are optionally equipped with up to six actuators (depending on the desired version), with which you can flexibly adjust the spa table according to your wishes via a hand control.
- * The areas that are **not** actuator-operated in the respective versions (headrest / armrests) can be adjusted pneumatically using a gas spring with a lever.

10.3 Before first use

- Make sure that the safety socket for the MLW is properly grounded and has the correct power voltage (230 V AC).
- Before setting up, make sure that sufficient space is provided for the MLW.



10.5 Gas springs

- The two armrests and the headrest on the MLW F1 with 4 actuators are adjusted using a gas spring (pneumatic); on the MLW F1 with 6 actuators, only the headrest is adjustable pneumatically.
- ❖ If you make an adjustment using the gas spring lever, you **only** need to operate the lever **when lowering**.
- To raise an armrest and / or the headrest again, perform a pulling movement upwards (without operating the corresponding lever).

10.6 Headrest

⚠ WARNING! Never exert physical force on the headrest, regardless of the setting of the lying surface. Non-compliance with this instruction may permanently damage the support structure of the MLW.

RISK OF TIPPING! RISK OF BREAKAGE! RISK OF INJURY!

- The headrest is manually continuously adjustable (see below, fig. 1,2 and 3).
- By pressing the lever on the side of the gas spring (see below, fig. 1), the headrest can be tilted as required (positively and negatively by 30° each) and locked by releasing it.
- ➤ See also chapter 10.5 GAS SPRINGS.

- The upholstery of the headrest is equipped with a nose slit for back massages. For this purpose, the headrest is equipped with a separate upholstered part which can be removed (see below, fig. 4).
- ❖ By placing an optionally available face gel cushion (see below, fig. 5) on the headrest, the face of the person to be treated can be additionally supported (s. also chapter 23.1 GEL CUSHION FOR NOSE SLOTS).

The "DENTALAX" NECKREST is optionally available for the MLW. (s. chapter 23.3 NECKREST "DENTALAX"). The NECKREST "DENTALAX" provides anatomical support for the cervical vertebrae and increasing the lying sensation considerably.

NOTICE! Do not lean against the headrest! Never stand, rest, or sit on the headrest; otherwise you may permanently damage it! RISK OF DAMAGE!

10.7 Armrests

⚠ WARNING! Never exert physical force on the armrests, regardless of the setting of the lying surface. Non-compliance with this instruction may permanently damage the support structure of the MLW. RISK OF TIPPING! RISK OF BREAKAGE! RISK OF INJURY!

NOTICE! Please note that the armrests must always be in the basic position (see below, fig. 6) before adjusting the position of the backrest. Otherwise, the armrests may collide with the floor, become trapped and/or seriously damaged (see fig. below, fig. 7 and 8).



10.7.1 Pneumatically adjustable armrests

- ❖ The armrests of the MLW F1 can be lowered or raised manually using a gas spring in the same way as the headrest (s. also chapter 10.5 GAS SPRINGS).
- ❖ The pneumatically adjustable armrests of the MLW F1 can also be swiveled.
- ❖ By operating the lever on the respective side and exerting slight pressure, they can also be adjusted continuously.
- * This makes the spa table ideal for back massages (s. fig. below).
- By swinging down the armrests, you can also move closer to the head of the person being treated during cosmetic treatments or facial massages.



10.7.2 Electrically adjustable armrests (optional equipment)

- ❖ Electrically adjustable armrests for the MLW F1 MEDIUM and LARGE are optionally available for an extra charge.
- For the MLW F1 SMALL electrically adjustable armrests are **not** available.

- 1. On the side of the armrests is the control button (s. fig. below) for adjusting the armrests.
- 2. Press and hold the corresponding arrow on the control button (s. fig. below) to lower or raise the armrests.
- 3. When the button is released, the movement stops immediately.
- For the **direction of movement**, please observe the arrow symbols on the control button.

10.8 Legrest

- ❖ The legrest of the MLW can be electrically adjusted independently of the backrest using the hand control (s. chapter 11.5 ADJUSTMENT OF THE LEGREST).
 - The seat area must be raised for this (s. chapter 11.4 ADJUSTMENT OF THE INCLINATION OF THE SEAT AREA).

10.9 Backrest

❖ The backrest of the MLW can be adjusted electrically (s. chapter 11.3 ADJUSTMENT OF THE BACKREST).

11. Electrical adjustments

- ❖ The electrical adjustments of the MLW are made, among other things, with a hand control.
- ❖ Optionally, the adjustments can also be made with an infrared remote control or a foot control (s. chapter 12. FOOT CONTROL and chapter 13. INFRARED REMOTE CONTROL).
- If you have chosen the VIBRO WELLNESS 10 option, an additional hand control is supplied for this option; s. chapter 16. VIBRO WELLNESS 10 (OPTIONAL EQUIPMENT).



For safety reasons, the spa table only moves if you keep a button of the hand control pressed. When you release it, the movement stops immediately.

11.1 Hand Control

The hand control is a cable-connected control. It enables the operation of the electrically controllable functions.

- Saving certain spa table positions is described in MEMORY FUNCTIONS OF THE HAND CONTROL (s. chapter 11.1.2).
- ❖ You can control each of the 4 actuators by pressing the corresponding pushbutton pairs (level 1, standard mode, black labelling).
- ❖ Furthermore, you can adjust and save up to eight memory positions (level 2, shift mode, grey labelling).


The hand control has 12 buttons; the upper 8 buttons are assigned to **both** levels.

11.1.1 Lock function / lock button of the hand control

❖ The MLW F1 is equipped with a hand control LOCK FUNCTION to protect it from unauthorized use.

ACTIVATING THE LOCK FUNCTION

- 1. To activate the lock function of the hand control, press the LOCK BUTTON (2 / hold it down) and then immediately (within one second) press the SHIFT BUTTON (4).
- 2. Keep <u>both buttons</u> pressed until an acoustic signal sounds.



- 3. The LED indicator of the LOCK BUTTON lights up.
- 4. The operation of the spa table is now blocked.

DE-ACTIVATING THE LOCK FUNCTION

To release the hand control, press the LOCK BUTTON (2 / hold it down) and then immediately (within one second) press the SHIFT BUTTON (4).

5. Keep <u>both buttons</u> pressed for approx. 3 seconds until an acoustic signal sounds.



- 6. The LED indicator of the LOCK BUTTON goes out.
- 1. The operation of the spa table is now enabled.

NOTICE! To prevent unauthorized use of the MLW F1, always activate the lock function of the hand control when leaving the treatment room.

11.1.2 Memory functions of the hand control

- The hand control of the MLW F1 has eight memory positions (memory positions on level 2: M1 / M2 / M3 / M4 / M5 / M6 / M7 / M8).
- ❖ The memory function saves the treatment positions you want and thus makes your work easier. Use the buttons M1 M8 (s. fig in chapter 11.1 HAND CONTROL).

STORING THE MEMORY POSITIONS:

1. Adjust the desired position as usual.



2. Press the SHIFT BUTTON (4). The LED indicator **lights up.** (LEVEL 2 OPERATION).



3. Press the MEMORY BUTTON (3).



4. Then press the desired MEMORY BUTTON M 1 - M 8.

M1-M8

5. When the position has been successfully stored, an acoustic signal will sound.

RECALLING THE MEMORY POSITIONS:

1. Press the SHIFT BUTTON (4). The LED indicator **lights up.** (LEVEL 2 OPERATION).



2. Press and **hold** the corresponding MEMORY BUTTON M 1 - M 8 **until** the stored memory position is reached.

M1 - M8

ONLY FOR MODELS WITH ELECTRICALLY ADJUSTABLE ARMRESTS:

If your MLW is equipped with electrically adjustable armrests, the positions of the armrests adjusted during storing of a treatment position are also stored; i.e. when a memory position is recalled, the armrests are also moved to the position they were in during storing.

11.2 Adjustment of the working height

- ❖ For adjustment of the WORKING HEIGHT, press the corresponding push-button pair (**A** / **A1**); s. fig. in chapter 11.1 HAND CONTROL.
- ❖ For the direction of movement, please observe the arrow symbols on the hand control.
- ❖ The horizontal WORKING HEIGHT of the **MLW F1 WOOD** is adjustable from approx. 58 cm to approx. 91 cm (with the feet turned in).
- The horizontal WORKING HEIGHT of the **MLW F1 SOFT** is, adjustable from approx. 63 cm to approx. 96 cm (with the feet turned in) due to the slightly thicker upholstery.
- ❖ By unscrewing the feet (up to approx. 3 cm), you can increase the working height slightly.
- The ENTRY HEIGHT is the lowest adjustment of the seat. This is indicated in the horizontal position of the seat.
 - ➤ MLW F1 Wood = approx. 58 cm / seat in horizontal position
 - ➤ MLW F1 Soft = approx. 63 cm / seat in horizontal position

11.3 Adjustment of the backrest

- ❖ The inclination of the backrest can also be adjusted using the hand control.
- ❖ For adjustment of the BACKREST press the corresponding push-button pair (**B** / **B1**); s. fig. in chapter 11.1 HAND CONTROL.
- ❖ For the direction of movement, please observe the arrow symbols on the hand control.

⚠ **WARNING!** When adjusting the treatment position, make sure that there are no body parts or objects between the spa table's parts. RISK OF CRUSHING!

NOTICE! Please note that the position of the backrest may only be adjusted when the armrests are in their basic position. Otherwise the armrests may collide with the floor, become trapped and/or seriously damaged; see also fig. 6,7 and 8 in chapter 10.7 ARMRESTS.

11.4 Adjustment of the inclination of the seat area

- The inclination of the seat area can also be adjusted using the hand control using the electrically adjustable knee bend; s. fig. in chapter 10.4 VIEW (EXAMPLE: MLW F1 WOOD).
- ❖ It covers the complete thigh area up to the knee bend.
- For adjustment of the INCLINATION OF THE SEAT AREA, press the corresponding push-button pair (**C** / **C1**); s. fig. in chapter 11.1 HAND CONTROL.
- ❖ For the direction of movement, please observe the arrow symbols on the hand control.

11.5 Adjustment of the legrest

- ❖ The inclination of the legrest can also be adjusted using the hand control. The seat area must be raised for this (s. chapter 11.4 ADJUSTMENT OF THE INCLINATION OF THE SEAT AREA).
- ❖ For adjustment of the INCLINATION OF THE SEAT AREA, press the corresponding push-button pair (**D** / **D1**); s. fig. in chapter 11.1 HAND CONTROL.
- ❖ For the direction of movement, please observe the arrow symbols on the hand control.

12. Foot Control

- ❖ The foot control (see below, fig. 9) can be connected as an option to the hand control or the infrared remote control.
- The foot control consists of a right and a left part connected to an electronic part (see below, fig. 10) on which the light diodes are located.
- ❖ The foot control allows control of the basic functions as well as recall of previously stored memory positions.
- When purchasing an MLW F1, one control can be selected: hand control, infrared remote control, or foot control.

 Only one of these is included in delivery; the other two can purchased at extra cost.



SELECT FUNCTIONS:

	> Serves as STORAGE BUTTON when the memory function is selected.
	R 2 / Right part of the foot control:

ADJUSTING THE ACTUATORS:

- 1. Select the actuators you want to adjust (height, backrest, inclination of the seat area, legrest) with the **R 2** pedal on the **right** part of the foot control. To do this, press the **R 2** pedal repeatedly until the LED of the desired actuator lights up on the central electronic part (s. fig. 10).
- 2. Press pedals **L 1** or **L 2** on the **left** part of the foot control to extend or retract the selected actuator (s. fig. 9). For the direction of movement, please see the arrow symbols on the stickers of the foot control.

STORING A MEMORY POSITION:

- 1. Adjust the desired treatment position as usual.
- 2. Press the **R 2** pedal of the **right** part of the foot control repeatedly until the **lower diode** of the central electronic part lights up (s. fig. 10).
- 3. Press the **R** 1 pedal to save the treatment position.
- 4. Now select the corresponding memory buttons **L1** (Memory 1) or **L2** (Memory 2) on the **left** part of the foot control.

 Press and hold the **L1** or **L2** pedals until an acoustic signal sounds.
- 5. The adjusted treatment position is stored.

RECALLING A STORED MEMORY POSITION:

- Two memory positions can be recalled using the left part of the foot control.
- 1. Press the **R 2** pedal of the **right** part of the foot control repeatedly until the **lower diode** of the central electronic part (s. fig. 10) lights up.
- 2. Then press and hold the pedals **L 1** or **L 2** of the **left** part of the foot control until the stored treatment position is reached.

ONLY FOR MODELS WITH ELECTRICALLY ADJUSTABLE ARMRESTS:

If your MLW is equipped with electrically adjustable armrests, the position of the armrests adjusted during storage of a treatment position is also stored; i.e. when a memory position is recalled, the armrests are also moved to the position they were in during storage.

13. Infrared remote control

- The infrared remote control enables wireless operation of the electrically controlled functions. The four actuators can be adjusted individually at the touch of a button. In addition, you can store and recall up to eight memory positions.
- To ensure the function of the remote control, the remote control must have a free connection to the infrared receiver. Please point the remote control at the center of the bed.





For safety reasons, the spa table only moves if you keep one button of the hand control pressed.

When you release the button, the movement stops immediately.

When purchasing an MLW F1, one control can be selected: hand control, infrared remote control, or foot control.

Only one of these is included in delivery; the other two can purchased at extra cost.

13.1 Operation

The individual functions (height, backrest, inclination of the seat area and legrest) are operated electrically. To control the corresponding functions, press the respective button on the remote control.

MEMORY FUNCTION

STODING A MEMORY DOSITIONS

❖ The memory function allows you to store up to 8 frequently used positions using the buttons M 1 to M 8 on the remote control (LEVEL 2 MODE).

LOCK BUTTON:

The remote control is equipped with a lock button to protect it from unauthorized use.

LOCKING THE REMOTE CONTROL:

1. To lock the remote control, press and **hold** the LOCK BUTTON for **three seconds** until an acoustic signal sounds.



2. Operation of the remote control is now blocked.

UNLOCKING THE REMOTE CONTROL:

1. To unlock the remote control, press and hold the SHIFT BUTTON and then immediately press and hold the lock button for two seconds until an acoustic signal sounds.





2. You can now access the remote control functions.

14. Smart Thermo heating system (optional equipment)

- ❖ The lying surface of MLW can be heated to maximize the treatment comfort. The Smart Thermo is a pre-programmed and fully automatic heating system which allows a comfortable operation. The intelligent Smart Thermo heating system is integrated into the upholstery of the MLW and works with modern microprocessor technology. The Smart Thermo heating system for the MLW is optionally available for an additional charge.
- Due to the pre-programmed microchip, you **only** must switch on the Smart Thermo with the "On" button to start the <u>automatic</u> heating program. For quick heating of a cold lying surface, after starting the Smart Thermo will operate with max. power during the pre-heating period. The heating program of the Smart Thermo is fully automated and switches off automatically after a total running time of 100 minutes.
- s. chapter 14.1 OPERATION / BUTTON -ON-
- The heating parameters of the Smart Thermo can be programmed and saved if desired (s. chapter 14.1 OPERATION). If desired, you can set 5 heating levels using the control panel of the Smart Thermo heating system (s. fig. in chapter 14.1).
- ① Check the current temperature before using the MLW. Disconnect the MLW from the mains when it is not used for a longer period, e.g. during the night.

⚠ WARNING!

- 1. Do not use the Smart Thermo when your customer
 - has got a pacemaker.
 - > is pregnant.


- You can operate the heating system using the 4 buttons (s. fig. below: CONTROL PANEL OF THE SMART THERMO HEATING SYSTEM).
- ❖ The setting of the heating power and the time selection is indicated by a 10-level LED bar-diagram.

- Press this button to switch **on** the Smart Thermo.
- 1. When the Smart Thermo is switched on, it starts heating at the <u>maximum</u> heating / power level for **5 minutes** (**level 5**: the 2 **red** LEDs (**E**) are illuminated).
- 2. After the 5 minutes have elapsed, the Smart Thermo will keep heating at the minimum heating / power level automatically for additional **95 minutes** (level 1: the 2 blue LEDs (A) are illuminated).
- 3. After a total time of **100 minutes**, the Smart Thermo will be switched off automatically.
- * This sequence is pre-programmed.
- The **heating / power level** <u>and</u> the **heating time** of the Smart Thermo can be changed at any time by using the corresponding buttons (s. description below:

 TEMPERATURE SELECTION BUTTON / TIME SELECTION BUTTON).



BUTTON -OFF-:

• Press this button to switch **off** the Smart Thermo.



❖ Press this button to adjust the **temperature** of the Smart Thermo for the setting of the required heat.

FIVE HEATING / POWER LEVELS ARE AVAILABLE:

> By pressing the button once more (six times) the selection cycle will begin at level 1 again



TIME SELECTION BUTTON:

- * Press this button to set the required **heating time** of the Smart Thermo.
- **Ten time settings** (in 10-minutes intervals) are available which are displayed on the LEDs (10 LEDs).
- You can select a heating time from 10 minutes up to 100 minutes by pressing the TIME SELECTION BUTTON one or several times.
- Thereby one illuminated LED corresponds to 10 minutes.
- When the desired time selection has elapsed, the Smart Thermo switches off automatically.

EXAMPLE:

You wish to set a medium heating / power level (level 3) of 30 minutes. Please proceed as follows:

1. Switch on the Smart Thermo by pressing the button -ON-



2. Then select the TEMPERATURE SELECTION BUTTON Press this button repeatedly until the two yellow LEDs (C) are illuminated (s. fig. below).



- 3. The appliance is now set to medium heating / power level (level 3).
- 4. Then select the TIME SELECTION BUTTON



5. Press this button repeatedly until three of the ten LEDs are illuminated (two **blue** LEDs <u>and</u> **one green** LED / s. fig. below).



- 6. One illuminated LED corresponds to a heating time of 10 minutes.
- 7. Now the appliance heats for 30 minutes at the selected heating / power level.
- 8. After the set time has elapsed the Smart Thermo switches off automatically.
- If you wish to quit the heating time **earlier**, press the button to switch off the Smart Thermo.
- ❖ When programming the Smart Thermo it does not matter whether you wish to set the time at first and the temperature secondly or vice versa.
- ❖ It is not possible to switch on the heating function without the time selection. The <u>minimum heating time</u> is 10 minutes (**one** illuminated LED). The maximum heating time is 100 minutes (ten illuminated LEDs).
- ❖ The selected settings can be checked at any time by pressing the relevant button.
- The Smart Thermo is equipped with a memory function, which enables the previous settings automatically after power up.

15. Audio Relax Headrest (optional equipment)

The AUDIO RELAX HEADREST is optionally available for the MLW, for an additional charge. The AUDIO RELAX HEADREST is equipped with integrated speakers and guarantees a pleasantly relaxing sound experience with the greatest comfort.

This option supports optimal relaxing of your customers and adds an individual touch to your massages. Two speakers built into the side of the headrest support the massage by providing a unique sound experience for your clients. The volume is **not** intended to provide sound in rooms.

16. Vibro Wellness 10 (optional equipment)

❖ The VIBRO WELLNESS 10 FUNCTION for the MLW is optionally available for an additional charge. VIBRO WELLNESS 10 is a pleasantly massaging vibration system and includes many various adjustment options.

⚠ WARNING!

- 1. Do not use the option Vibro Wellness 10 if your customer
 - has got a pacemaker.
 - > is pregnant.
 - > is affected by thrombosis.
 - > suffers from pain due to unknown reasons.
- 2. Apply to healthy people only.

⚠ **WARNING!** Do not open the housing of the hand control! Non-compliance will expire the guarantee.





16.2 Operation

HOW TO START A MASSAGE:

You can start a massage by pressing the FOLLOWING BUTTONS:

ON / OFF BUTTON (1)

- ❖ When the massage unit is operated for the first time, the setting INDIVIDUAL is activated.
- ❖ All massage motors operate in the manufacturer's setting (intensity level 2 / medium intensity).
- ❖ When the massage unit has been operated before, the previously-set program is started again (INDIVIDUAL, PULSE OR WELLNESS MASSAGE).

INDIVIDUAL BUTTON (2)

- ❖ When the massage unit is operated for the first time, the manufacturer's setting is activated (intensity level 2 / medium intensity).
- ❖ When an individual setting has been set before (s. below: INDIVIDUAL SETTING), the previously-set setting is started again.

Pulse-massage button (3)

❖ Start this massage with the **first** of the three pulse-massage program.

WELLNESS-MASSAGE BUTTON (4)

❖ Start this massage with the **first** of the three wellness-massage program.

INTENSITY BUTTONS (5-9)

- ❖ Pressing one of these buttons sets the relevant massage motor to intensity level 1.
- Please note: Doing so will overwrite a previously-set individual setting (s. below: INDIVIDUAL SETTING)!

INDIVIDUAL SETTING (2):

- > Start the massage by pressing the INDIVIDUAL BUTTON (2).
- When the massage unit is operated for the first time, the manufacturer's setting is activated (intensity level 2 / medium intensity).
- Now you can set each motor to **three levels** of intensity using the INTENSITY BUTTONS (5) (9).
- The levels are indicated on the LED-display as follows.

- ➤ When the lowest intensity (level 1) has been reached, press one of the INTENSITY BUTTONS (5) (9) again to switch off the relevant motor.
- When you switch off all massage motors, the massage is stopped.
- You can change from the manufacturer's setting (intensity level 2 / medium intensity) to your individual setting by pressing the INDIVIDUAL BUTTON (2).
- The individual settings are saved after the massage.

Pulse-massage (3):

- ➤ Press the PULSE-MASSAGE BUTTON (3) to start the massage with the **first** of the three programs.
- ➤ Press the PULSE-MASSAGE BUTTON (3) a second time to start the **second** program.
- Press the PULSE-MASSAGE BUTTON (3) a third time to start the third program.
- When you press the PULSE-MASSAGE BUTTON (3) a <u>fourth</u> time, the **first** program will be started again.
- You can select three levels of speed with the + and BUTTONS (10).
- You can select **three levels** of intensity with the INTENSITY BUTTONS (5) -(9).
- **Please note:** The PULSE-MASSAGE will be restarted in the manufacturer's setting.

WELLNESS-MASSAGE (4):

- ➤ Press the WELLNESS-MASSAGE / WAVE BUTTON (4) to start the massage with the **first** of the three programs.
- Press the WAVE BUTTON (4) a second time to start the **second** program.
- Press the WAVE BUTTON (4) a third time to start the **third** program.
- When you press the WAVE BUTTON (4) a <u>fourth</u> time, the **first** program will be started again.
- You can select three levels of speed with the + and BUTTONS (10).
- You can select three levels of intensity with the INTENSITY BUTTONS (5) (9).
- Please note: The WELLNESS-MASSAGE will be restarted in the manufacturer's setting.

HOW TO FINISH A MASSAGE:

- ❖ A timer finishes a massage after 15 minutes automatically.
- ❖ If you want to stop the massage before, press the ON / OFF BUTTON (1).



The motors of the VIBRO WELLNESS 10 FUNCTION become louder when operating at the highest setting. This is not a cause for concern or complaint.

17. Triple Airback (optional equipment)

❖ The Triple-Airback technology is an electro-pneumatically 3-zone-lumbarsupport-system of the upholstery and optional available for the MLW F1; for an additional charge.

⚠ **WARNING!** Read the following instructions carefully before you operate the Triple Airback for the first time.

⚠ **WARNING!** Do not operate the Triple Airback system, when it does not work properly or is visibly damaged. Ensure that it cannot be operated by third parties accidentally.



17.1 Scope of delivery

Control unit incl. 3 rocker switches for the adjustment of the air cushions (s. chapter 17.3 CONTROL PANEL).

17.2 Characteristics

- * The electrically-powered pneumatic Triple Airback System enables individual and ergonomic adjustments of the upholstery.
- ❖ There are three air cushions under the mattress underlay:
 - Air cushion 1 and air cushion 2 at the lumbar area.
 - Air cushion 3 at the thigh area.

17.4 Operation

- * The air cushions can be inflated individually with an electrically operated pump:
- 1. **Rocker switch 1** on the control panel (s. above, chapter 17.3 CONTROL PANEL; fig. 10) operates air cushion **1** situated at the back section (upper part of the lumbar area).
- 2. Press the same button in opposite direction to let the air out.
- Rocker switch 2 (air cushion / lower lumbar area) and rocker switch 3 (air cushion / thigh area) work in the same way.

NOTICE! Do not pump the air cushions too much; otherwise the air cushions can be damaged.

18. Multimedia Sound System (optional equipment)

- The integrated MULTIMEDIA-UNIT (MMU) offers a modern interface between various playback devices and your Spa Table.
- * The speaker, which is integrated in the Spa Table, enables you to relax to your own favourite music.
- ❖ The various players are <u>not</u> included in the scope of delivery.

- 7. **Never** insert foreign objects into the MMU.
- 8. Keep the MMU away from open flames, e.g. candles etc. RISK OF FIRE!

- 10. Never expose the MMU to temperatures above 35 °C.

18.5 Playback of music / iPhone, Bluetooth, USB, AUX





19. Initialization of the software


